Cookies required

Definition of a cookie

Cookies are small text files such as an image or software that may be stored on your devices (computer, tablet, smartphone, etc.) when you visit a website. Cookies allow a website to recognise you, remember your preferences and help you continue browsing by keeping track of the pages visited.

We use cookies to improve your experience on the Site to suit your preferences. These cookies are very important to help us make online services easier to use, track the use of our Site and improve the services we offer you. It is hereby specified that we do not use advertising cookies on our Site.

Cookies applied

1. Cookies essential for browsing

These cookies are essential and must always be activated. They allow us to recognise you during the same session. Under no circumstances are these cookies used for commercial marketing or targeting purposes. They are intended to enable you to view the Website and to use the features of the Site under optimal conditions.

Once your choices have been saved, we will only use the cookies you have authorised to read or write. Any cookie saved before your settings will always be on your device and you can delete it in the settings of your browser.

If your device is used by more than one person, you are responsible for shared use and the configuration of your browser settings for cookies.

Installation of a cookie rejection module

If you do not want the data related to your visit to be collected and analysed, you may at any time object to this for the future. You can install an additional module on your browser to technically block such collection and analysis. For technical reasons, this cookie can only be used with the browser in which it was installed. If you delete cookies overall or if you use another browser or device, you will need to re-install the cookie rejecting performance cookies.
